Talent Show Rules & Regulations:

- 1. Auditions are open to children ages 10-18. Children may enter the talent show as a solo group act. (Group can be no more than 6.)
- 2. Acts can include singing, dance, instrument or drama performance. No other forms of talent will be included. Lip syncing is prohibited.
- 3. Audition video must be no more than 3 minutes in length. Any video running longer than the 3 minutes maximum will have a 15 point deduction from the overall score.
- 4. Audition video must be age-appropriate and meet the committee's standard of appropriateness in terms of language, subject matter, and attire. Acts having ANY DOUBTS about the appropriateness of their material MUST discuss this with the talent show committee BEFORE SUBMITTING AUDITION TAPE 631-473-5220.

Please understand that what is seen on TV or in the movies is not necessarily appropriate for this setting.

5. Your audition video must be uploaded to Vimeo (Vimeo.com) by 11 pm, Sunday, April 11, 2021. At the same time, all signed paperwork along with the \$20 application fee must be submitted via email to:

- 7. Tryouts are closed to anyone on the talent show committee, judges or GPJAC board members, or their relatives.
- 8. Contestants are responsible for their own music, props, and costumes.

- 9. Contestants are responsible for rehearing and polishing their acts. 10. No political presentations.
- 11. Talent Show contestants and their parent(s)/ guardians agree to ALL Talent Show rules and regulations.
- 12. The act must be entertaining and considered legitimate talent as determined by the judges.
- 13. Contestants should consider and will be judged on the following items when selecting and presenting a talent act:

Stage presence 20pts Creativity 20 pts Costume 10 pts

Overall Performance: 20 Entertainment Value: 20

100 point value

15 pts will be deducted if performance is over 3 minutes.
